Although physiologic design is shaped by natural selection and not by purpose, this teleologic approach can help us understand why cells and organs are structured the way they are. It also helps us understand the rationale behind responses to stress that are advantageous in the short term but ultimately may lead to system failure. Understanding the "why" aids retention and gives future health care providers a powerful tool for anticipating how and understanding why disease processes present clinically in the way that they do.
